TERMS & CONDITIONS OF ENTRY

- 1. Entry is free and open to anyone 12 years and under, subject to parent or guardian's consent.
- 2. Entries are limited to one (1) entry per person.
- 3. Entry into the competition is deemed acceptance of these Terms & Conditions of Entry.
- 4. Entries include the following information:
 - The entrant's name and age, along with the name of the parent/guardian
 - Telephone number and/or email address (this is how we will notify the winners)
 - All participants must have parent or guardian's consent to enter the competition.
- 5. Competition closes at 5pm AEST on 20 December 2021.
- 6. Winners will be notified by email by 5pm AEST on 24 December 2021.
- 7. Landcom accepts no responsibility for completed entries not received by the closing time and date for any reason whatsoever.
- 8. This Competition is in no way sponsored, endorsed, administered by or associated with Instagram/Facebook.
- 9. By entering, you agree to a complete release of Instagram/Facebook from any or all liability in connection with this Competition.
- 10. You acknowledge that, unless indicated otherwise, the completed artworks and the participants' first names may be published on Landcom's social media pages or displayed at SMNW Places across the Northwest Places program in either digital or print formats.

WHO DECIDES WHO WINS?

- 17. Completed entries will be judged on:
 - Overall appearance
 - Colour combination
 - Creativity

PRIZES

- One winner will be selected from each age group (6 years and under, 7–9 years and 10-12 years).
- Each winner will receive a \$100 Event Cinema gift voucher (Prize). *
- Landcom in its sole discretion reserves the right to determine the allocation of prizes, which are not transferable, exchangeable, or redeemable for cash.
